# TERMS & CONDITIONS RELATING TO SALES OF “RIAS EXPO 2014” (Roma International Air Show and Expo 2014)

## INTRODUCTION

The 3<sup>RD</sup> edition of RIAS 2014 - Roma International Air Show 2014 – now called “RIAS EXPO 2014” will take place at Ostia, Roma, Italy, from the 27<sup>th</sup> to the 29<sup>th</sup> of June 2014 and is organized by ASD Team Italia, Via delle Ortensie n. 57 – 00040 Rocca di Papa (RM).

These “**Terms and Conditions**” at RIAS EXPO 2014 are applicable to all Exhibitors, their Contractors and Sub-Contractors, and to all Participants.

Please read all sections carefully: any change to these Terms and Conditions will only be applicable if confirmed in writing by the Organizers (Team Italia). ## EXHIBITION REGULATIONS AND PROCEDURES

Exhibitors must ensure that the following regulations and procedures are read by all stand and space contractors prior to commencement of work.

### 1) GENERAL REGULATIONS

#### a) Composition of “RIAS EXPO 2014”

The RIAS EXPO 2014 is composed of an Outdoor Exhibition (Standard Pitch and self-build stand, commercial or not); a Static Aircraft Park; a Flying Display.

This Application to Exhibit Form covers only the Outdoor Exhibition (Standard Pitch and self built stand). Applications related to the Static Aircraft Park and to Aircraft exhibiting on Flying Display should be completed on the appropriate Form in the web site [www.romairshow.net](http://www.romairshow.net).

#### b) Eligibility to “RIAS EXPO 2014

All companies wishing to participate at RIAS EXPO 2014, can hire standard pitch or a space for self-build pitch, commercial (possibility to sell merchandise and goods) or not commercial (not selling, just exposure of goods). The type of products exposed can be examined by the Organizers who has the right to decide to accept or to not accept the application form of participation. For commercial pitch or commercial space is requested a surcharge of 10% of the total price.

**N.B.:** those who are intended to hire a pitch or a space in order to sell food or drinks to public, must have a regular license to sell these products; also, they must fill the application form at Circostrizione di Ostia and pay the requested fee. Those who fails to comply with any of these provisions shall be liable to a fine. The Organizers are not responsible to pay the mentioned fee not the fine.

### 2) SPACE ALLOCATION PROCEDURE; PAYMENT

#### a) Applications for Outdoor Stand AND Space

Applications for Outdoor Stand and Space, must be filled and submitted on the official Application Form. All the applications to Exhibit Form must be completed and signed by the Contractor or by an authorized representative of the Exhibitor and sent by mail to ASD Team Italia, via delle Ortensie n. 57 – 00040 Rocca di Papa (RM), or sent by fax to the number +39 069498676, or by e-mail to [info@romairshow.net](mailto:info@romairshow.net).

The signed Application Form represents a contract between the Exhibitor (or their Agent) and the Organizers (Team Italia). By signature of the Application to Exhibit Form, the Exhibitor or their Agent, agrees to be bound by the Terms and Conditions contained therein.

The Organizers shall have the right to determine the allocation of space and pitch and shall be entitled to vary the location of any stand and space.

All the Exhibitors will have the same rights and privileges. The Organizers have the right to assign stand and space in consideration of their availability, giving priority to aeronautical and aerospace companies.

#### b) payment

A copy of the transfer order must be attached to the completed Application to Exhibit Form. If you are an exhibitor from outside Italy and are VAT exempt, please provide a VAT exemption certificate and we will ensure that your invoices are amended accordingly.

All bank charges and transfer charges must be paid by the Exhibitor and payment can only be accepted in Euros. If paying by bank transfer, the Exhibiting Company's name must be quoted on the

**c) Withdrawal from Stand or Space at RIAS EXPO 2014**

If the Exhibitor does not accept the space allocation or the pitch assigned, the Exhibitor will be entitled to withdraw from the Exhibition in accordance with the Exhibition Regulations.

**1) Withdrawal from the Exhibition before 15 December 2013**

The 15% of the payment will be retained by the Organizers

**2) Withdrawal from the Exhibition after 15 December 2013 and before 15 April 2014**

The 50% of the payment will be retained by the Organizers

**3) Withdrawal from the Exhibition after 15 April 2014**

If the notice of withdrawal is received after 15 April 2014, the Exhibitor shall be liable for the full Exhibition Charges.

**3) EXHIBITOR'S RESPONSABILITIES**

**Stand and Space Exhibits, Health and Safety Considerations**

Exhibitors should be aware of their responsibilities and obligations under Health and Safety law to ensure the safety of visitors inside of their stands during the opening hours of the exhibition.

Exhibitors must maintain their exhibits on their stands throughout the period of the trade exhibition. (See the regulations of the EXPO when available).

**4) TRADEMARK**

'Roma International Air Show' is a registered trademark of ASD Team Italia. Any Exhibitor or contractor wishing to use the Organizers trademark must obtain prior approval, in writing, from the Organizer.

**5) STAND FITTING AND CONSTRUCTION**

Exhibitors should note that certain sites within the outdoor areas are not level. Exhibitors with self-build stands are advised to survey their allocated area prior to the pre-show period. Arrangements must be made with the Organizers at least 5 days before the intended site visit.

No electrical power or water supplies are available. Exhibitors can bring a power supply.

**NOTE IMPORTANT:** Exhibitors' stands are provided for the sole purpose of displaying products and services. Exhibitors can use a small fridge inside of the stand and can consume hot/cold drinks and pre-prepared sandwiches or snacks, but cooking and serving of food products on the Exhibition Stand is prohibited. Except for those who have regular license.

No Exhibitor may sell any merchandise without the express written permission of the Organizers.

**6) APPROVAL OF STAND DESIGN AND NAME**

Exhibitors must submit for the approval of the Organizers a dimensional drawings showing a plan layout and all elevations of their proposed stand, and they also must provide details of the company name to be shown on the stand name sign.

**7) DISPUTES AND INTERPRETATION**

All disputes shall be subject to interpretation pursuant to the Italian law

**8) INSURANCE**

**a) Exhibitors' Insurance**

Exhibitors are required to obtain and provide insurance protection for all Third Party risks with a minimum cover of € 3.600,00 and to ensure that the Organizers are covered by such insurance protection in respect of the Exhibitor's participation in the Exhibition. In the event that the Exhibitor does not have an adequate extant Insurance prior to the Air show, the Exhibitor must apply to the Organizers' Insurance Brokers. Failure to comply with this requirement will result in the Exhibitor being prohibited from access to the Exhibition.

Display Aircraft are subject to additional insurance requirements as set out in the Flying Regulations.

**b) Loss, Damage or Injury**

Exhibitors will be held responsible for loss of, or damage or injury to property (including other exhibits) and persons howsoever caused by themselves, their servants or agents, and the Organizers shall not be liable in respect thereof for any reason including the negligence of the Organizers, their servants, agents or employees save that this exclusion shall not apply to the Organizers' liability (if any) for death or personal injury. This provision is specifically agreed by the Exhibitor to be fair and reasonable.

**9) CANCELLATION**

In the event of cancellation for any reason whatsoever of the Exhibition other than by reason of breach of this Contract by the Organizers, the Organizers shall be entitled to retain all sums paid by Exhibitors which are reasonably considered by the Organizers to be necessary to cover the expenses incurred in connection with the Exhibition. This provision is specifically agreed by the Exhibitor to be fair and reasonable.

**10) FORCE MAJEURES**

**a)** A party shall not be in breach of its obligations to the other party under this Contract nor liable for any failure or delay in performance of any of its obligations there under arising from or attributable to acts, events, omissions or accidents beyond its reasonable control (Force Majeure Event), including but not limited to any of the following:

- (a) Acts of God, flood, earthquake, windstorm or other natural disaster;
- (b) epidemic or pandemic;
- (c) war, threat of or preparation for war, armed conflict, imposition of sanctions, embargo, breaking off of diplomatic relations or similar actions;
- (d) terrorist attack, civil war, civil commotion or riots;
- (e) nuclear, chemical or biological contamination or sonic boom;
- (f) any law or government order, rule, regulation or direction, or any action or intervention taken by a government or public or regulatory authority, including but not limited to imposing an embargo, export or import restriction, quota or other restriction or prohibition, failing to grant a necessary license or consent or revoking any previously granted license or consent;
- (g) fire, explosion (other than in each case one caused by a breach of contract by the party seeking to rely on this clause) or accidental damage;
- (h) loss at sea;
- (i) extreme adverse weather conditions;
- (j) interruption or failure of utility service, including but not limited to electric power, gas or water;
- (k) any labour dispute, including but not limited to strikes, industrial action or lockouts;
- (l) non-performance by suppliers or subcontractors; and
- (m) collapse of building structures, failure of plant machinery, machinery, computers or vehicles.

If the Force Majeure Event prevails for a continuous period of more than 30 days, any party may terminate this Contract by giving written notice to the other party with immediate effect. However, if the Force Majeure Event is to prevail or is likely to prevail over the duration of the Exhibition itself, then either party can terminate this Contract by written notice with immediate effect. Such termination shall be without prejudice to the rights of the parties in respect of any breach of this Contract occurring prior to such termination.

**b)** The Exhibitor is advised to insure itself from and against the impact of any Force Majeure Event which affects the Exhibition or its participation in the Exhibition

**11) ACCEPTANCE OF TERMS AND CONDITIONS**
